JEANNE CLERY DISCLOSURE/VAWA ACT

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act is a Federal statute requiring colleges and universities participating in federal financial aid programs to maintain and disclose campus crime statistics and security information.

The Violence Against Women Reauthorization Act of 2013 amended the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery Act) by adding requirements to distribute written notifications that explain the rights, options, and resources for victims of sexual assault, dating violence, domestic violence and stalking. This document provides that information.

UNSURE OR WHERE TO START?

DO YOU NEED MEDICAL ATTENTION?

You can receive medical treatment at any medical facility; however, certain providers have specially-trained staff to help survivors of sexual assault and/or can offer a sexual assault forensic exam (SAFE).

PRESERVATION OF EVIDENCE

Preserving evidence in all cases of sexual assault is imperative. For example, avoid showering, douching, eating, drinking, or brushing your teeth if at all possible, after a sexual assault; this could destroy evidence. Bedding or clothing worn during or after the assault should be preserved and collected by law enforcement. A forensic sexual assault exam may be conducted and the evidence stored even if you elect not to have law enforcement involvement.

ORDERS OF PROTECTION

You can also access orders of protection within the state of Florida as within Florida Southern College. Depending on the nature of the incident, the College may be able to issue a campus-based no contact order to prevent contact between two individuals. COMPLAINT OPTIONS

- 1. To initiate a College (non-criminal) investigation (students):

- 2. To initiate a College (non-criminal) investigation (employees):

- 3. To initiate a criminal investigation:
 - a. The Office of Campus Safety and Security staff can connect you with a Lakeland Police Department officer that is assigned to Florida Southern College. You can reach them 24/7 at **863-680-4305**.
- 4. You also have the option not to notify law enforcement directly (if over the age of 18).

Victims have the right to notify police or decline police involvement. If the victim chooses to notify the local police, campus police can assist with that notification. Law enforcement can collect and store evidence even if the victim wishes not to involve police so that it's available should the victim change their mind at a later time.

CAMPUS INVESTIGATION PROCESS

The formal complaint will be reviewed by the Co-Title IX Coordinators to determine if the reported violation initiates the Title IX grievance process. If it does, an investigation is launched. The investigators will either be Florida Southern College trained staff members or the College may determine that outside investigators will be utilized. An investigation will determine if the respondent has violated campus policy and is subject to disciplinary action.
