What is Just Ask?

Florida Southern College's initiative to reduce all forms of Title IX sex discrimination through prevention and education. Preventing sex discrimination is more than just the law. It is a reflection of who we are as FSC community members under the Cornerstone.

What is Title IX?

Title IX is more than Athletics. Items covered under Title IX include sex discrimination, domestic violence, dating violence, stalking, and any unwanted sexual experience. Title IX also includes access to higher education, career education, math/science/technology access, a discrimination-free learning environment and education for pregnant and parenting students.

I am not sure about consent. How do I know if consent was given?

- a. If you are silent, that does not mean "yes."
- b. Once you consent, it can be withdrawn at anytime from moment-to-moment and day-to-day.
- c. If under 18, giving consent is not possible.
- d. Consent must be informed, voluntary, and mutual, and can be withdrawn at any time.
