**Release, Hold Harmless and Conduct Agreement**

As a participant in Intramural Sports at Florida Southern College, I am fully aware of the risks and hazards connected with my participation in such sports ("Activity"), and hereby elect to voluntarily participate in the activity, knowing that the activity may be hazardous to myself or my property. I **voluntarily assume all responsibility for any risks of loss, Property damage, or personal injury**, that may be sustained by me, on any loss or damage to property owned by me, as a result of being engaged in the activity, **whether caused by the negligence of Florida Southern or it's employees or agents** or otherwise.

I hereby **Release, Waiver, Discharge and Covenant not to sue** Florida Southern College, the Board of Directors, their officers, servants, agents or employees (hereinafter "Releases") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or **caused by the negligence of the Releases** or otherwise, while participating in Intramural Activity at Florida Southern College. It is my express intent that this Release and Hold Harmless Agreement (hereinafter "Agreement") shall be deemed as a **Release, Waiver, Discharge and Covenant not to sue** the above named Releases. I hereby further agree that this Agreement shall be constructed in accordance with the laws of the State of Florida.

As a participant, if I berate an Intramural Sports employee before, during or after a contest, I and/or my team could be suspended from all intramural activities for one semester or more. If a coach or spectator associated with my team berates an intramural employee, then it could affect the sportsmanship rating of my team and/or my team could be suspended from play for the remainder of that activity.
