<u>RETURNING STUDENTS</u> may visit Portal Registration to make necessary schedule adjustments until January 17, 2022, before 5:00 p.m.

<u>NEW AND TRANSFER STUDENTS</u> must visit the Registrar's Office to make schedule adjustments until January 17, 2022, before 5:00 p.m. <u>All first semester FSC students will be required to complete a schedule adjustment form that must include a faculty advisor's signature</u>. Forms are available on the FSC web site (search FSC, Registrar's Office, Forms, Schedule Adjustment Form (Add/Drop).

<u>ALL STUDENTS</u> must visit the Registrar's Office to withdraw from a course beginning January 18, 2022, and prior to 5:00 p.m. on March 25, 2022. <u>W</u> grades will be posted on the student's academic record. All students must cc both the course faculty/professor and his/her advisor on a withdrawal request email to registrar@flsouthern.edu in order to withdraw from a course. The student is responsible for submitting this email withdrawal request to the Registrar's Office. Verbal notification to a faculty/professor or failure to attend class does *not* constitute a withdrawal form. Students who abandon a course without filing the appropriate form may receive a failing grade. Course withdrawal forms are available in the Registrar's Office or on the FSC web site.
