### **Biographical/Historical Sketch**

Incorporated in 1944, the Winter Garden Citrus Products Cooperative was a co-operative founded by R. D. Keene to process citrus juice into concentrate for several growers. Keene served as President from its incorporation until 1966 when he stepped down stating medical issue. Under Keene, the plant expanded several times to become one of the largest concentrate plants in the state. As of 2016, the business seems to be inactive.

### **Scope & Content Note**

This collection contains the corporate Articles of Incorporation, minutes from meetings from 1944-1984 and bulletins dating from 1976-1990. Within the corporate minutes and bulletins are agreements, correspondence, waivers and consents, as well as some financial information, bylaws, seasonal information, and stock samples. Information is organized chronologically then alphabetically.
